AN ORDINANCE APPROVING RESOLUTION NO. 1, SERIES OF 2020 OF THE LOCAL PRICE COORDINATING COUNCIL OF THE MUNICIPALITY OF MAINIT ON PRICE CONTROL AND PRESCRIBING PENALTIES FOR VIOLATIONS THEREOF

Co-Sponsor: Hon. Jerry D. Madera

WHEREAS, in the interest of public service more particularly due to the ill-effects of Corona Virus Disease 2019 (COVID-19), the local officials strongly impose to constitute a Local Price Coordinating Council and/or to organize a more purposive and sustained monitoring of selected prime commodities pursuant to Republic Act 7581, otherwise known as the Price Act and Republic Act No. 71 also known as Price Tag Law. Such action is necessary and urgent to forestall further hardships among our people;

WHEREAS, in line with this, the Municipal Mayor of Mainit, Hon. Crisanta O. Mondano has issued Executive Order No. 34, series of 2020, entitled "An order reorganizing the Local Price Coordinating Council of the Municipality of Mainit" which contextualizes the composition of the council, its roles and functions, and its secretariat;

WHEREAS, the composed Local Price Coordinating Council has gathered for a meeting to perform its role and function to provide effective and sufficient protection to consumers against overpricing, profiteering and hoarding due to the threat of COVID-19 pandemic;

WHEREAS, the Council has approved Resolution No. 1, series of 2020, (attached herewith for reference), posing its decision to implement price control of prevailing prices of agri-fisheries products, basic necessities and prime commodities based on what is provided for by Republic Act No. 7581 as amended by Republic Act No. 10623;

WHEREFORE:

Section 1. Title. This Ordinance shall be known as “An Ordinance Approving Resolution No. 1, series of 2020 of the Local Price Coordinating Council of the Municipality of Mainit on Price Control and Prescribing Penalties for Violations thereof”;

Section 2. Declaration of Policy. The declaration of this policy is primarily in adherence to Republic Act. No. 7581, which says:

It is the policy of the State to ensure the availability of basic necessities and prime commodities at reasonable prices at all times without denying legitimate business a fair return on investment.

It is also a declared policy of the State to provide effective and sufficient protection to consumers against hoarding, profiteering and cartels with respect to the supply, distribution, marketing and pricing of said goods, especially during periods of calamity, emergency, widespread illegal price manipulation and other similar situations.

To these ends, the State shall:

1. Develop, adopt and promulgate measures to promote productivity in basic necessities and prime commodities;
2. Develop an improved and efficient transport and distribution system;
3. Develop, adopt and promulgate measures to stabilize prices at reasonable levels;
4. Institute appropriate penalties for illegal price manipulation and other violations of this Act; and
5. Establish a mechanism that will readily protect consumers from inadequate supply and unreasonable price increase on occasions of calamities, emergencies and like occurrences.

Section 3. Coverage. This Ordinance shall cover all businesses operated within the territorial jurisdiction of the Municipality of Mainit.

Section 4. Penal Clause. Any person who violates this measure shall be imposed accordingly in the following manner:

First Offense	- Php1,000.00
Second Offense	- Php1,500.00
Third Offense	- Php2,500.00 and cancellation of business permit



Section 6. Effectivity. This Ordinance shall take effect immediately approval and upon posting for three (3) days outside the Mainit Public Market and Magpayang Public Market and in three (3) conspicuous places in the Municipality of Mainit.


