**A COMPREHENSIVE ORDINANCE TO FIGHT COVID-19 IN THE MUNICIPALITY OF MAINIT AND IMPOSING PENALTIES THEREOF**

**WHEREAS**, the entire world is indeed in crisis due to the woeful Corona Virus Disease 2019 or COVID-19, a new strain of infectious respiratory disease which originated from Wuhan, China as confirmed by the World Health Organization (WHO);

**WHEREAS**, this pandemic COVID-19 spread rapidly which urged the President of the Philippines, His Excellency Rodrigo R. Duterte to place the entire country under a state of calamity thru Presidential Proclamation No. 929 which also enjoins every local government unit to render full assistance to and cooperation with each other and mobilize the necessary resources to undertake critical, urgent, and appropriate disaster response aid and measures in a timely manner to curtail and eliminate the threat of COVID-19;

**WHEREAS**, Section 16 of Republic Act No. 7160, otherwise known as Local Government Code of 1991, provides that every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare;

**WHEREAS**, upon knowing the dreadful effect of this COVID-19, there is a need to adopt concrete measures to prevent, contain and restrict the spread of infectious/communicable diseases, pandemics, epidemics, and/or outbreaks of diseases;

**WHEREFORE:**

**BE IT ORDAINED** by the Sangguniang Bayan of the Municipality of Mainit, Surigao del Norte in session assembled that:

**Section 1. Title.** This Ordinance shall be known as **“A Comprehensive Ordinance to Fight COVID-19 in the Municipality of Mainit and Imposing Penalties Thereof.”**

**Section 2. Definition of Terms.** For the purposes of this Ordinance, the following terms shall have the following meaning:

- a. **Face Mask** - shall mean a protective device that is firmly fastened over the face and covering at least the nose, mouth and chin which serves as a protection or barrier against the spread or infection of COVID-19 virus and other airborne pathogens, such as surgical masks, N95 masks, face shields, and shall include ear-loop mask, cloth mask, handkerchief, bandana or scarf, do-it-yourself masks and other similar contraptions or device that is sufficient to prevent the spread of the disease.
- b. **Public Place** - shall include all areas in the Municipality of Mainit that are accessible or open to the public or for collective use and enjoyment, regardless of ownership or right to access, including but not limited to, offices, restaurants, malls, convenience stores, sari-sari stores, carenderias, markets, public streets, walkways/sidewalks, parkway, alley, parks, playgrounds, plaza, hotels, motels, condominiums, transportation terminals, workplace, and transportation vehicles.
- c. **Gatherings** – an activity that assembles mass of people to conduct any kind of activity, but not limited to, religious activity; private activities such as birthday, anniversary celebrations and the like; sports activities; and other assemblies.
- d. **Social Distancing** - also called “physical distancing,” means keeping space between yourself and other people outside your home at least one (1) meter apart.

**Section 3. Objective.** This Ordinance is aimed to establish the emergency response against COVI-19 in pursuance to Municipal Executive Order Numbers 30, 31, 32, 33, 34 and 35, all series of 2020 of Mainit, Surigao del Norte.

**Section 4. Coverage and Applicability.** This shall apply to all individuals residing and establishments operating within Mainit, Surigao del Norte and shall remain in effect until the lifting of the Community Quarantine of Mainit.

**Section 5. Regulatory Provisions.** For the purposes of this Ordinance, hereunder are the regulated acts, to wit:

**5.1 On Public Transportation**

- a. Tricycle/Traysikad may be allowed to operate within the jurisdiction of Mainit with a maximum of three (3) passengers only.
- b. Fare guide shall be followed per approved matrix. However, negotiations may be allowed between the driver and the passengers as deemed necessary with ceiling that it shall not exceed the maximum fares good for three (3) passengers.

**5.2 On Policy on Physical/Social Distancing**

- a. Physical/Social distancing shall be strictly observed in public places and/or social gathering/activities at least one (1) meter apart.

**5.3 On Travel Pass**

- a. Travelling to and fro home and workplace may be allowed with necessary "work pass" issued by the Mayor or Punong Barangay concerning the public or private employees and/or workers including agricultural sector.

**5.4 On Wearing Face Mask**

- a. Wearing of face mask or any face cover shall be observed in public places, in social activities, while on travel, and in the workplace except in the farm and in home.

**5.5 On Curfew Hours**

- a. Curfew hours for all residents shall be strictly implemented from 9:00 PM to 4:00 AM of the next morning, except for frontliners and emergency cases subject to Department of Health guidelines and protocols.
- b. Ages 20 and below and 60 years old and above are not allowed to go outside of their respective houses except for valid and/or emergency reasons subject to Department of Health guidelines and protocols.

**5.6 On Back-riding Policy**

- a. Habal-habal or single motors are not allowed to operate for public transportation in observance of a physical distancing.

**Section 6. Prohibited Acts.** This Ordinance shall strictly prohibit the following:

**6.1 Liquor Ban**

- a. Public drinking is strictly prohibited however, buying and selling is regulated accordingly. Only those who have business permit can sell liquor products while only those aged 20 years old and above can buy.

6.2 Social gatherings are strictly prohibited.

**Section 7. Establishment of Isolation Facility.** The LGU and Barangays shall identify isolation facility which shall house Person Under Investigations (PUIs) where such facility shall pass thru the Department of Health guidelines in its establishment. The Municipal Health Officer shall determine the qualification of patients to be confined at the isolation facility.

**Section 8. Penalty.** Violators of this Ordinance shall be fined as follows:

- 1<sup>st</sup> Offense - Php1,000.00
- 2<sup>nd</sup> Offense - Php1,500.00
- 3<sup>rd</sup> Offense - Php2,500.00 and imprisonment of not more than one (1) month or upon discretion of the Court.

However, minor offenders shall be placed under the custody of Municipal Social Welfare and Development Office in accordance with law.

**Section 9. Implementing Rules and Regulations.** The Municipal Government of Mainit shall issue the implementing rules and regulations pertaining to this Ordinance as maybe necessary.

**Section 10. Separability Clause.** If for any reason, any provision or provisions of this Ordinance is declared unconstitutional or invalid by the reviewing authority, the remaining sections or provisions not affected thereby shall remain and continue in full force and effect.

**Section 11. Repealing Clause.** All ordinances, resolutions, rules or regulations which are inconsistent with or contrary to the section or provisions of this Ordinance are hereby repealed, amended or modified accordingly.

**Section 12. Effectivity.** This Ordinance shall take effect immediately upon approval and shall remain effective until the State of Calamity is lifted.
