AN ORDINANCE AMENDING SPECIAL SB-MSN MUNICIPAL ORDINANCE NO. 2020-057, SERIES OF 2020 KNOWN AS "A COMPREHENSIVE ORDINANCE TO FIGHT COVID-19 IN THE MUNICIPALITY OF MAINIT AND IMPOSING PENALTIES THEREOF"

Sponsor: Hon. Jerry D. Madera

WHEREAS, in aid of legislation, there were members of the Local COVID-19 Task Force of this Municipality being invited to be present in the session serving as resource personnel to purposely equip the August Body as to the recent updated health protocols, policies and guidelines, and other related vital issues and concerns to fight against pandemic COVID-19;

WHEREAS, with all the necessary information from such resource personnel, a very encouraging and enlightening discussion were achieved which resulted to take appropriate amendments under the status of modified General Community Quarantine (MGCQ) pursuant to the Public Health Emergency as declared by our National Government;

WHEREFORE:

BE IT ENACTED by the Sangguniang Bayan of the Municipality of Mainit, Surigao del Norte in session assembled, that:

Section 1. Title. This Ordinance shall be known as "Amended Comprehensive Ordinance to Fight COVID-19 in the Municipality of Mainit and Imposing Penalties thereof."

Section 2. Amended sections covered under Special SB-MSN Municipal Ordinance No. 2020-057, series of 2020 are specified hereunder, to wit:

a. **Section 2 on the Definition of Terms**, by adding one item to be defined as follows:

Public Drinking – drinking session in conspicuous public places, displaying drunkard behavior.

b. **Section 5 par 5.6 on Back-Riding Policy**, by inclusion of another stipulation as paragraph b, which states that:

“Couple ride and members of the family are hereby allowed on this policy provided that they can present a copy of marriage certificate and/or certification document from the Punong Barangay as immediate members of the family. Provided further, that back-ride passenger is limited to one (1) only.”

c. **Section 8 on Penalty Clause** is hereby redefined as follows:

8.1 On violating Section 5 (paragraphs 5.1, 5.2, 5.3, 5.4 and 5.5 under Special SB-MSN Municipal Ordinance No. 2020-057, se. 2020)

1 st Offense	-	Php300.00
2 nd Offense	-	Php500.00
3 rd Offense	-	Php1,000.00 and/or imprisonment of not more one (1) month or upon discretion of the court

8.2 On violating Section 6 (paragraph 6.1 under Special SB-MSN Municipal Ordinance No. 2020-057, se. 2020)

**On selling liquor without business permit*

1 st Offense	-	Php300.00
2 nd Offense	-	Php500.00
3 rd Offense	-	Php1,000.00 and imprisonment of one (1) month or upon discretion of the Court

**On business establishment with business permit caught selling liquor products to 19 years old and below*

1 st Offense	-	Php300.00
2 nd Offense	-	Php500.00
3 rd Offense	-	Php1,000.00, cancellation of business permit and imprisonment of one (1) month or upon discretion of the Court

8.3 Violation involving Minors

All minor offenders shall be placed under the custody of Municipal Social Welfare and Development Office in accordance with law. And, the parents/guardians of the minors shall automatically be held liable for the corresponding penalty of the committed violation as clearly stated under this Ordinance.

All penalties defined above shall be complied in accordance with the existing standard policies.

Section 3. Implementing Rules and Regulations. The Municipal Government of Mainit shall issue the implementing rules and regulations pertaining to this Ordinance as maybe necessary.

Section 4. Separability Clause. If for any reason, any provision or provisions of this Ordinance is declared unconstitutional or invalid by the reviewing authority, the remaining sections or provisions not affected thereby shall remain and continue in full force and effect.


Section 5. Repealing Clause. All ordinances, resolutions, rules or regulations which are inconsistent with or contrary to the section or provisions of this Ordinance are hereby considered superseded.

Section 6. Effectivity. This Ordinance shall take effect immediately upon approval and shall remain effective until the State of Calamity is lifted.


